Graduate Education - Faculty Development Underway

Graduate medical education is not what it used to be-at least not for the faculty responsible for its delivery. For those of us who trained before the 1990s, the environment was one where teaching was excellent and much of it was delivered by other residents, who were senior to the learners. Senior faculty teaching was often limited to "attending rounds" and supervision by attendings was often indirect. In the 1990s, duty-hour restrictions were placed on residencies. These restrictions came about first in New York State as a result of the deliberations of the Bell Commission, which concluded that serious mistakes occurred when fatigued residents were insufficiently supervised. The Accreditation Council for Graduate Medical Education (ACGME) followed suit in the late 1990s and implemented duty-hour limitations for all post-graduate training programs nationally. This shift has resulted in significantly more "handson" teaching and direct supervision by senior faculty members.

Concurrent with the duty-hour restrictions was the initiation of the Outcomes Project by the ACGME. With this effort, the ACGME charged residency programs with determining how to measure competency in six core areas for all physicians. These included medical knowledge and patient care, which were the areas most residency programs already assessed. In addition, four important competencies were added: communication and interpersonal skills, professionalism, systems-based practice, and practice-based learning and improvement. In the first

decade of this century, the ACGME has refined its expectations surrounding the competencies and has prescribed "milestones" for resident learners in their advancement from one level to the next and their advancement to graduation.

These changes require a new set of skills of the core clinical faculty. No longer can a teacher simply demonstrate knowledge and skill in patient care. The faculty member must have the ability to assess a resident in all of the six areas of competency required of an independent physician. These skills are not ubiquitous among faculty and require some level of training. For this reason, Bassett has embarked on an initiative to develop its own specially trained "Education Faculty".

Prior to 2011, Bassett sponsored episodic faculty development programs, with internal and external content experts, usually based around one or more of the six competencies. These were independent programs and did not have a necessary unifying theme. In 2011, the Office of Medical Education launched a program in conjunction with an internationally recognized group of medical educators from the Royal College of Physicians (RCP) in London. Faculty from Bassett, both in the residencies and student programs, were invited to participate in two-day workshops on teaching and evaluation techniques, facilitated by the group from the RCP. The first of these was held in December 2011 and the next in November 2012.

I suspect that most of us who trained at Bassett highly value the collegiality and emphasis on fundamentals that were passed along to us by our mentors and teachers and would like to see these same values embraced by present and future generations of students, house staff and faculty. However, as we are all aware, there are more and more mandates and regulations, and fewer and fewer sources of funding for medical education.

One of the truly great resources at Bassett is its supporters. Many have contributed to Bassett

From these sessions, a group of faculty was identified who were committed to the educational mission at Bassett and were invited to become part of a new Education Faculty. We have engaged our partners from the RCP to facilitate twice-yearly workshops in Cooperstown. At these workshops, there is continued effort to refine the microskills of the participants as teachers, but also for this group to develop an "education curriculum" that will be launched for all Bassett senior staff that consider themselves faculty for students and residents. The Education Faculty will serve as core staff to "teach the teachers".

The group plans to have a curriculum developed and ready for deployment in 2016. While

the Education Faculty is currently composed of a nucleus of 15 members, the intent is for this to be a fluid group which takes on new members as interest and competence dictate. The group currently has a monthly Journal Club which meets the second Thursday of each month at noon in the Fieldstone conference room. All interested faculty are invited.

Faculty training of this type requires ongoing support which has come in part from the existing medical education endowment built upon contributions of the Bassett Medical Alumni Association. This undertaking and continuous enhancement to the medical education program will enable Bassett to sustain its tradition of excellence in education and patient care.



Franck Retires as Associate Dean

Walt Franck, M.D., retired from his position as associate dean of Columbia-Bassett Medical School in January. With more than four decades as a clinician at Bassett working directly with residents and medical students, and over 20 years of leadership experience as the director of medical education from 1995 to 2002, and finally associate dean of the medical school since 1998, Franck is in a unique position to offer his outlook on the future of medical education and the medical education mission at Bassett.

Parting Thoughts on the Future of Medical Education

Since Bassett was founded as a community-based hospital with academic missions, an essential component of its construct was the existence of graduate and undergraduate medical education programs.

Over the years residencies in many disciplines evolved. Those in Medicine, Surgery and a Transitional Year have not only survived the dramatic regulatory and societal changes we have witnessed, but have seen substantial growth in sophistication, training and experience of faculty, and redesign of curricula to adapt to changes in health care while constructing a learning environment with the processes best suited for education. Our residencies have been effective in recruiting faculty for us, particularly, but not exclusively, in medicine, surgery and their specialties. The future will focus on fellowship program development and studying the wisdom and feasibility of introducing a Family Medicine Residency Program.

Teaching medical students has, likewise, been part of the core of Bassett's medical education commitment. For decades students from many schools, particularly Columbia University College of Physicians and Surgeons, Albany Medical College, School of Medicine and Dentistry at the University of Rochester. Dartmouth Medical School, and Upstate Medical University at Syracuse, rotated through clerkships and electives with us. These experiences provided exciting and challenging opportunities for students and faculty alike. Few trainees, however, ultimately returned as residents or attendings. With the creation of the Longitudinal Integrated Curriculum combined with a program crafted to teach students skills in performance engineering to improve quality of care and reduce cost. Bassett was able to

design a major clinical year experience that led to the genesis of the Columbia-Bassett program.

This joint venture has proven to be quite successful. It has required the reprioritization of our commitment to Columbia for all rotations, clerkships and electives, with residual opportunities available for students from other schools. In the future, we hope that students who choose to come to Cooperstown for their clinical training will return either as residents and/or as members of our attending staff. For this program to succeed, the engagement of all involved, on both campuses is essential. This alternative model of education needs to be supported, trusted, respected and economically enabled by both organizations.

The educational efforts of those involved including our physicians, advanced care practitioners, and administrators must be known, understood, appreciated and supported by all, the Board of Trustees, the Administration, and the Staff. Much is asked of our faculty in terms of time and effort including faculty development training and actual teaching. This is being done at a time when the organization is in need of maximal possible productivity efforts. We must develop fair methods for evaluating the extent and quality of each faculty member's teaching commitment, followed by providing economic rewards to acknowledge the importance and value of this mission. Existing new sources of income for our organization, like meaningful use dollars and expanded insurance programs, can be enhanced with learning the tools for practicing with greater efficiency and safety. These resources may help us manage more patients and thus generate additional revenue.

Weil Named Senior Associate Dean




Henry Weil, M.D.

Henry Weil, M.D., has been named Senior Associate Dean for Education at Bassett Healthcare, Columbia University. Weil has been involved with the innovative Columbia-Bassett Medical School

program since its inception. This sophisticated joint program provides a longitudinal curriculum and course of study focused on ethics, evidence-based medicine, health care system management, and leadership.

"The program's No. 1 goal is to train great doctors," said Weil, "but there's a big secondary goal as well—teaching these students how the health care system works, and problem solving so they may be health care leaders of the future."

The first year and one half of largely pre-clinical studies, takes place at Columbia College of Physician and Surgeons in New York City. The second phase, two and one half years, is based at Bassett and consists of a required one-year experience followed by a year and a half of electives and pursuit of an area of concentration. The program graduated its first class of ten students in 2014.


Kenneth Singer, M.D.

Harvey Gurian, M.D.,

Harvey Gurian, M.D., Bassett Psychiatrist-in-Chief 1959-89, passed away at age 88 from complications following surgery on February 14, 2015 in Cambridge, Mass. A native of Canada, he obtained his M.D. from the University of Toronto, followed by an internship at the Saskatoon City Hospital and then a psychiatry residency at the Brooklyn State Hospital. An advertisement brought him to Bassett. As he told John Davis, M.D. in 2009, "To have a teaching hospital in a rural setting was very unusual then. There were very few psychiatrists in rural areas at that time. You know when we came here it was a very idealistic place. It was very small, everybody knew everybody." When he came to Bassett he was the only psychiatrist between Albany and Binghamton, and finding an associate was difficult.

Gurian set up a premiere two-year psychiatry residency at Bassett in conjunction with Columbia University's Psychiatric Institute. He was an active teacher of psychiatry to the Intern staff as an advocate of the bio-psycho-social model of medicine developed at the University of Rochester. He radiated good cheer.

Harvey Gurian had a 58-year devoted marriage to Helen Supple Gurian who for several years worked with him as a psychiatric social worker. A Type 1 diabetic from age 28, Gurian took scrupulous care of himself and was eventually awarded the Joslin Medal for "50 Courageous Years with Diabetes." He is survived by his wife and children, Anne (Anthony) of Medford, MA, John (Lourdes) of San Antonio, Robert of Cooperstown, Patrick (Katharine) of Wayne, Pa. and five grandchildren.

Dorothy Thomas

Dorothy "Dottie" Thomas died at home near Seattle on January 9, 2015 at age 92. The widow of E. Donnall Thomas, M.D. who had also died at age 92 in 2012, Dottie was known as "the Mother of Bone Marrow Transplants" because of her right-hand management of her husband's immunological and transplant work through the years. Recruited from Harvard Medical School in 1955, Dr. Thomas assembled the team that led to the first successful bone marrow transplantation for acute leukemia in 1959, leading to his Nobel Prize in Medicine in 1990. As Bassett's Theodore Peters, Ph.D., described it to John Davis, M.D., "Dottie managed all of his literature and research affairs, and his role as a family." Dr. Thomas also persuaded his wife to allow him to bring the (research) dogs to their home in Middlefield, N.Y., five miles out of town. By the time the new canine facility was completed in 1963, the Thomas family was caring for 56 lively beagles that had survived a marrow transplant. According to Dr. Thomas, "Dottie told me if we got one more, I'll leave!" Needless to say, she never left.

Paul W. Scharff, M.D.

Paul W. Scharff, M.D. passed away in Chestnut Ridge, N.Y. on April 29, 2014 at age 83. A graduate of Case Western University School of Medicine, Scharff was a Rotating Intern at Bassett Hospital in 1956-57. He and his wife, Ann, were friends of fellow Intern John Davis, M.D. and his wife Jean. Scharff became a psychiatrist, and he and Ann co-founded a summertime residence for devotees of the philosopher Rudolf Steiner in 1966. Scharff explained his approach as, "What we are trying to do (for elders) is emphasize the human soul and spirit." His widow Ann Scharff survives him.

Elizabeth Davidson, R.N.

Elizabeth "Betty" Davidson, R.N. died at Otsego Manor on August 10, 2014 at age 91. She began at Bassett as a nurse's aide in 1942, received her R.N. degree from Columbia University in 1946, and except for a stint away from 1950 to 1957, spent most of her career at Bassett until retiring in 1985. A warm but strict member of the "old school" of nursing practice, she taught decades of nursing students, was a mentor to many members of the house staff and was one of the last at Bassett to wear a nurse's cap.
